#### 3.1 Media Evolution AB (Co-organiser,)

- Be helpful in providing contacts for accommodation for residents.
- To provide during 1 month;  
Office space in Media Evolution City  
Guided services- matchmaking and meetings  
Access and engagement of residents to activities organized by Media Evolution
- Full entry and participation at The Conference (22, 23 August, 2012)
- Invoice issued within 5 days after signed agreement

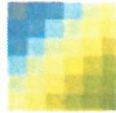
#### 3.2 Kosice-Europske hlavné mestokultúry 2013, n.o.

- Pay remuneration in amount of **4.282 €** through invoice provided by Media Evolution
- The payment (invoice) shall be made within 30 days after the invoice is delivered
- Provide an agreement on time schedule of stays of residents
- Provide professional guidance and coordination prior to, during and after the execution of the stay
- Financially provide the stay of residents during 1 month at Media Evolution City
- To provide transport allowance for residents

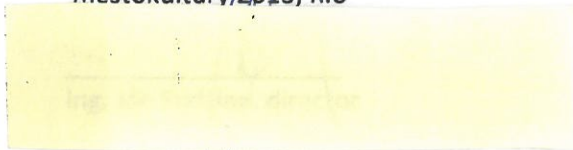

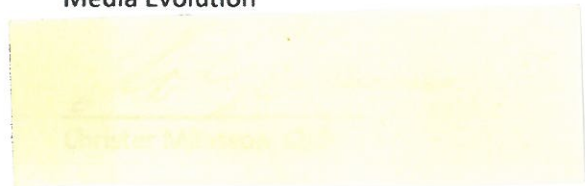
