**AGREEMENT №
For holding services**

Košice, 30.4. 2012.

KOŠICE – Turizmus hereinafter referred to as the “Contractor”, represented by MUDr. Renáta Lenártová on the one part, Košice 2013 n.o. represented by Ing. Ján Sudzina on second part and Individual entrepreneur Korsakov Sergey Aleksandrovich, Certificate of the individual entrepreneur state registration № 310774602701085 of January 27, 2010, registering authority: Federal Tax Service Interdistrict Inspectorate № 46 for the city of Moscow, on the other part, collectively referred to as the “Parties”, have concluded this agreement on the following:

1. Subject of Agreement

1.1. The Contractor undertakes to render services of organizing and holding the "coin exchange office" within the interactive exhibition game "Kartónové mesto", hereinafter referred to as the “Event”, organized from 20 to 27.5.2012 by Korsakov Sergey Aleksandrovich for the count of Košice 2013 n.o. in Košice within the framework of “Use the City” festival. The present agreement fixes the functioning of the coin exchange office, exchange rates between Euros and BT coins for the visitors within the "Event" and conditions of payment between the parties.

2. Rights and obligations of the Parties

2.1. Rights and obligations of the Contractor:

2.1.1 The Contractor undertakes to run the exchange office within "Kartónové mesto" from 24 to 27.5.2012, from 13:00 to 20:00. The Contractor will ensure the presence of at least one competent English – Slovak speaking person able to use the cash register during the time here defined and for needed preparation meetings.

2.1.2. The contractor undertakes to sell BT coins at the price of 50 euro cents and to buy them from visitors at the price of 40 euro cents in the limit of the amount of coins involved in the game. It will mean that at the end of the event contractor will have 10 eurocent from each transaction and money from BT coins from which reimbursement to Euros were not required from visitors.

2.1.3. The contractor undertakes bring his own cash register, to inform visitors of the condition of participation and to give them needed bills at each financial transaction.

2.1.4. The contractor undertakes to prepare on the 1.6.2012 a report of the financial activity of the "Event".

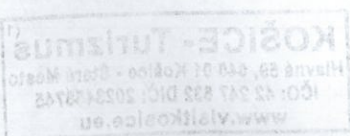
2.1.5 The contractor undertakes to pay cash at least on the 27.5.2012 to Korsakov Sergey Aleksandrovich the part of the benefices of the Coin Exchange office as defined in the point 3 of the present agreement and to give back the coins returned by visitors.

2.1.6. The Contractor undertakes to inform Parties immediately about any circumstances that put obstacles in the way of providing services which arise at the moment of providing services. The Contractor undertakes to take any measures possible in order to eliminate the circumstances that put obstacles in the way of providing services and minimize the negative consequences for the other parties.

2.2. Rights and obligations of the Korsakov Sergey Aleksandrovich

2.2.1 Korsakov Sergey Aleksandrovich undertakes to give to the bank the amount of BT coins necessary to run the event.

2.2.2 Karsakov Sergey Aleksandrovich undertakes to ensure that will be in use in the game only the number of coins that will be described in the signed protocol of exchange (annex 1) at the beginning and at the end of the game.



2.2.3. Karsakov Sergey Aleksandrovich undertakes to ensure the place in the Kartonove Mesto where the exchange office will be running and of the functioning of the game.

2.3. Rights and obligations of the Košice 2013 n.o.:

2.3.1. Košice 2013 n.o. is obliged to pay for the services of the Contractor in the amount and in the order stipulated by this Agreement in the point 3..

2.3.2 Košice 2013 n.o. undertakes to include logo of Visit Košice in the promotional material link with the Event.

3. Cost of services

3.1. The cost of services provided by the Contractor equals 96 (ninety six) Euro VAT included. The Contractor pays on his own all the other taxes payable according to the current legislation.

3.2. The all amount will be paid by Košice 2013 n.o. to the Contractor within 14 days after the Contractor issues the invoice at the end of the Event.

3.3. In order to cover their side costs, 18% of turnover of the Coin Exchange Office will be paid cash in Euro by the Contractor to Karsakov Sergey Aleksandrovich on the 27.5.2012 after signing the acceptance protocol and 2% of turnover will stay for the contractors.

4. Liabilities of the Parties

4.1. The Parties are liable for non-fulfillment or improper fulfillment of their obligations under this Agreement in accordance with the current legislation.

5. Other provisions

5.1. This agreement comes into force at the moment of its signing and is valid until the moment of signing of the Work Acceptance Certificate.

5.2. This agreement can be terminated earlier by the mutual written agreement of the Parties.

5.3. All the disputes and disagreements that may arise between the Parties as to this agreement will be settled by negotiations. In case there is no understanding between the Parties, the disputes will be solved in the order stipulated by the current legislation of the Slovak republic.

5.4. As to all the issues not specified by this agreement the Parties are governed by the current legislation of the Slovak republic.

5.5. This agreement is made in three copies that have equal legal force; one copy for each of the Parties.

5.6. Any amendments and addendums to this agreement are valid only if they are made in writing and signed by the Parties.
