- a. Should the Client wish to cancel this booking for any reason it shall inform the Agency in writing as soon as possible.
- b. Should the Agency wish to cancel this booking for any reason it shall inform the Client in writing as soon as possible.
- c. **Contract Confidentiality.** This contract is strictly confidential and its details must not be disclosed to any third party.
- d. **Morality Clause.** Should the Client endure unfavourable publicity of a substantive nature between the signing hereof and the date of the engagement which, in the reasonable opinion of the Agency diminishes the positive public relations value of the engagement, the Agency may cancel this contract by giving notice in writing at the earliest possible date.
- e. The Client warrants that all equipment supplied by it (whether directly or through a subcontractor) will be safe and in good order.
- f. If the engagement called for under this contract is rendered impossible by reason of flood, war, industrial disturbance, fire, lock-out, epidemic, acts of God, or for any reason of a similar nature beyond the control of the contracting parties, it is agreed that this contract shall be null and void.
- g. The Agency agrees that the Client will promote the event and it may wish to use the Talent's details and image to do so. The materials used in that case must be approved by The Agency. The usage of photographic images of the Talent might have to be licensed between third parties due to copyright issues.
- h. If any sum under the Agreement is not paid by the final date for payment then, without prejudice to the parties' other rights under the Agreement, that sum shall bear interest from the due date until payment is made in full at 1% per day.
- i. The Agency holds the right to decide whether the Talent gives interviews or not before, during and/or after the event. The Client agrees that no interviews will be scheduled unless agreed beforehand with the Agency. The Client undertakes to not ask the Talent directly to give any interviews in situ.
- j. The Agency allows the Client to use the footage or photographs from the event to their own promotional advantage, shall it always favour both the Talent and the Client.
- k. The Client will meet the requirements specified in ANNEX A.

ANNEX A: HOSPITALITY RIDER

The client will cover all expenses incurred by the Talent to attend the engagement.

- a. A travel allowance will be agreed between the Agency and the Client to cover flights and ground transportation in Talent's home city only.
- b. The Agency will book the flights, unless agreed otherwise.
- c. The Client must make the Agency aware of any Visa requirements involved in the travelling of the country where the event takes place and must provide assistance when necessary in order to obtain such Visa. All expenses associated will be covered by the Client.
- d. The Client must organise and cover all ground transportation in the city where the event takes place. It is expected that the Client will arrange transfers to and from the airport and to and from the venue (unless the hotel is located within less than 10 minutes away by foot from the venue).
- e. Accommodation must be provided by the Client for the days the Talent attends the event, with a minimum of two nights (day before the event and the day of the event), unless agreed otherwise.
- f. It is expected that the hotel room will be in acceptable sanitary conditions.
- g. The hotel room should have breakfast included and WIFI access. If there's a fee charged for these, it must be covered by the Client.
- h. A daily allowance will be agreed between the Client and the Agency to cover meals expenses and other possible incidentals throughout the duration of the Talent's trip.
- i. In the case the Client wishes to book any meals, these must be vegetarian.
